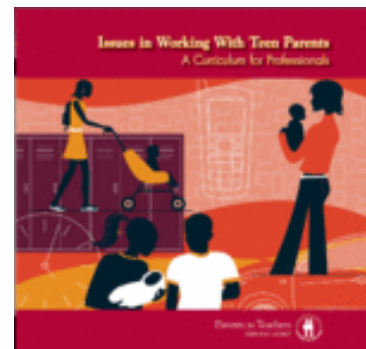
Issues in Working with Teen Parents
